6. Discuss the use of technology to support the family child care business, including ways to communicate with and support families, document the growth and development of young children, and maintain records and data.
7. Create a business plans that includes a program philosophy, mission statement, fee structure, hiring policy, budget, bookkeeping system, and marketing plan.
8. Summarize the professional responsibilities of the family child care provider, strategies for evaluating one's own performance, and ways to expand one's knowledge base in the field.
